

# OUR 25th ANNUAL CONFERENCE ON SOUTH ASIA Center for South Asia University of Wisconsin-Madison

The first Conference on South Asia of which we have any record took place on a Saturday in 1971, when a number of South Asia faculty met in Madison with a group of Wisconsin high school teachers to discuss the teachers' need for South Asia classroom materials. The Conference was repeated with a similar format during the next two years.

Then in 1974 the Conference added a few academic panels with formal papers and discussants. In 1975, reflecting one of the outreach activities of Wisconsin's South Asia Center, the conference was held on the campus of the University of Wisconsin-Oshkosh under the title "Wisconsin Conference on South Asia." About one hundred people attended that Conference. However, the logistics of holding a conference someplace other than Madison proved so overwhelming that from 1976 on the Conference has been a Madison event.

Titled the "Annual Conference on South Asia," the Conference was held for many years during the first weekend in November -- a weekend rarely in conflict with other academic conferences, but a weekend frequently marked by Wisconsin's first snow. In 1995, in an effort to avoid the snow, the conference was shifted to the third week in October. It snowed anyway.

Over the years Wisconsin's Annual Conference on South Asia has grown in size and the range of countries and geographical regions from which the participants have come; the excitement and number of panels (this year we have over 70); and the variety of accompanying association meetings and planning sessions.

We are glad you are here. Welcome to our 25th Annual Conference!

#### Tibetan-Buddhist Sand Mandala Construction and Rituals

The Term *mandala* has many meanings. In Tibetan Buddhism it can refer to any diagram used in meditation. The diagram may include figures of deities, bodhisattvas, or the Buddha himself, or it may represent the residence of deities, the universe, or reality.

On Sunday, October 13, in the central court of the University of Wisconsin Elvehjem Museum of Art, Tibetan monks of the Sera Je Monastery in India began carefully constructing a three-dimensional *mandala* using yellow, white, red, black, and green sand.

Visitors to the museum can view the construction of the sand mandala throughout the week.

On Sunday morning, October 20 between 11:15 and 11:45 a.m. visitors are invited to observe the final ceremonies and the destruction of the *mandala* -- a reminder of life's impermanence.
